2. Approval of Memorandum of Understanding between the Public Works and the Parks Department for the use of Indian Village Park land during the reconstruction of the Bluffton Rd Bridge.
3. Approval of Service Agreement between the City of Fort Wayne and Worx Companies for WO #0927P, 2025 On-Call Tree Removal Package. Compensation for services performed shall not exceed \$200,000.00.
4. Approval of Amendment #3 to Professional Services Agreement between the City of Fort Wayne and Donohue & Associates for Resolution #76929, Water Pollution Control Plant Aeration Diffuser Improvements. This amendment updates hourly rates for 2025.
