Re: Authority for the County of Westchester, acting by and through Westchester Community College, to enter into an agreement with the Peekskill School District for the provision of College-Level courses to the Peekskill High School students pursuant the P-Tech Grant for the period of July 14, 2025, regardless of when executed, to June 30, 2026, whereby the College shall be paid a total amount not-to-exceed \$18,160.00

On March 2023, the Peekskill City School District (the "School District") and Westchester Community College executed a Memorandum of Understanding ("MOU"), annexed hereto as Schedule A, in order to implement a New York State P-TECH Grant Program for the period July 1, 2024, through June 30, 2030.

The NYS P-TECH grant aims to prepare academically and economically at-risk students for the future by preparing them for high-skilled jobs in the fields of technology, and manufacturing.

School District now desires the College to provide said services to the School District and College agrees to provide such services pursuant to the New York State P-TECH Grant Program.

Therefore, Authority is hereby requested for the County of Westchester, acting by and through the Westchester Community College (the "College"), to enter into an agreement with the Peekskill School District (the "School District") whereby the College will provide college-level courses to the School District's students at one of its campuses and/or on campus at the School District's High School. Additionally, the COLLEGE shall host several campus visits for P-TECH

students and a Cybersecurity Camp at the COLLEGE's Valhalla Campus. (the "Services").

The proposed agreement will have a term commencing July 14, 2025, regardless of when executed, and terminating June 30, 2026. The School District will pay to the College an amount not-to-exceed Eighteen Thousand One Hundred Sixty Dollars (\$18,160.00) for providing these services (the "Agreement")

Westchester Community College (the "College") and Peekskill School District (the "School District"), collaboration will benefit both students and the community from the School District participating in the P-TECH Grant Program.

Pursuant to the terms of the proposed Agreement, College agrees to defend, indemnify and hold harmless School District, its officers, directors, agents, or employees against all claims, demands, actions, lawsuits, costs, damages and expenses, including attorneys' fees, judgments, fines and amounts, arising from any act, omission, error, recklessness or negligence of College, its officers, directors, agents or employees in connection with the performance of services pursuant to the Agreement.

This agreement is exempt from the operation of the Westchester County Procurement Policy pursuant to Section 3(a)(iii) in that it is an agreement with a political subdivision of the State of New York. The agreement is authorized pursuant to Section 6306.8 of the Education Law in that it is an agreement for a cooperative educational program with a school district.

Accordingly, I recommend adoption of the attached resolution.

Upon a communication from the President of Westchester Community College, be it hereby:

RESOLVED, that the County of Westchester, acting by and through Westchester Community College (the "College"), is authorized to enter into an agreement (the "Agreement") with the Peekskill City School District (the "School District"), whereby the College will provide college-level courses to the School District's students at one of its campuses and/or on campus at the School District's High School. The agreement is authorized pursuant to Section 6306.8 of the Education Law in that it is an agreement for a cooperative educational program with a school district; and be it further

RESOLVED, that the County Executive or his duly authorized designee be and hereby is authorized and empowered to execute any and all instruments and to take all action necessary to implement the purposes hereof.
