## 1. Standing Items

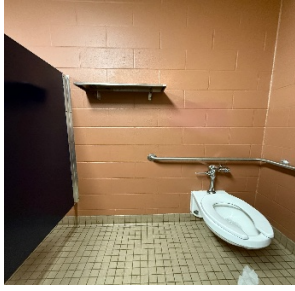
- 1.1 Any additions to the agenda?
