This request is for a non-competitive amendment between Cellco Partnership d/b/a Verizon Wireless (Cellco) and Denver International Airport (DEN). The telecommunications license provides cell phone service on airport property, including service in non-public areas such as tunnels, the airfield, the hotel conference center, and future developments outside of the terminal complex. The amendment is to update exhibit A to include a slightly larger footprint in one existing place, utilizing vacant area.

This Amendment aligns with Vision 100 pillars Growing Our Infrastructure and Maintaining What We Have. With the principle of enhancing the customer experience in mind, this amendment will enable more cellular reliability and redundancy by refining the existing space and utilizing the space for upcoming infrastructure to meet increased passenger volume as they traverse a larger and more efficient DEN space.
