2. 5 Revell Street – Camrin de Gast/Silopanna Woodworks LLC – Add retaining walls to the front yard, front walk and porch. Replace the existing brick with bluestone pavers and replace the timber retaining walls on the side and front of the house with stone, capped with bluestone. Apply a mineral limewash to exposed lower brick façade and chimney. An in-ground wood deck replaces the existing brick patio, walk and paver patio in rear yard. A cobblestone driveway and shortened walkway will replace the current paver driveway. Replace existing retaining wall in the rear yard with stone, capped with bluestone. A sitting wall will be constructed that abuts the inground deck and will match all retaining walls. At the rear of the home a granite border lines the property’s rear line, meeting with and matching the neighbors. (HPC-2026-00026)
