2. Findings of Fact November 25, 2025

- PORT-2025-00011 – The Point Condominiums:

Demolition of floating and fixed piers for a total of 2,602 SF over the water to be removed. Construction of 2,560 SF of floating pier (T-Dock), 903 SF of fixed pier including 630 SF of Zone 3 finger piers and 273 SF Loading Platform, 572 SF of Zone 3 Helical anchor bulkhead, 28 zone 5 reinforcement batter pile walls (piles only).

- PORT-2025-00012 – Spa Creek Marina Co., Inc. - Burnside Street:

Replace in-kind pier as floating pier: 6' x 223' pier

(2) 3' x 13' finger piers

(5) 3' x 14' finger piers

(4) 3' x 15' finger piers

(1) 3' x 16' finger pier

(33) mooring piles

Install 4' x 8' gangway

Replace in-kind pier as floating pier: 6' x 153' pier

(1) 3' x 13' finger pier

(6) 3' x 14' finger piers

(3) 3' x 15' finger piers

(27) mooring piles

3. Findings of Fact December 23, 2025

- PORT-2025-00014 - 7 LOUDON LN  
Construct a 27.2-foot by 29.4-foot by 14.2-foot tall replacement boathouse with a 503.28-square foot platform and replace-in-kind an adjacent 12-foot by 35-foot platform, all extending a maximum of 35 feet channelward of the mean high water line and raising both structures a maximum of 2 feet in elevation taller than the existing structures. Replace in kind a 252-foot long by 6-foot wide timber pier and raise a maximum of 2 feet in elevation taller than the existing structure, all within a maximum of 287-feet channelward of the mean high water line. Construct and backfill 48 linear feet of replacement bulkhead within a maximum of 18 inches channelward of a deteriorated bulkhead. Construct 124-feet of stone toe armor within 10-feet channelward of the existing bulkhead and replenish 28-feet of stone revetment within a maximum of 10 feet channelward of the mean high water line. Construct and backfill 56-linear feet of replacement bulkhead within the footprint of the existing deteriorated bulkhead with no channelward encroachment. Remove one mooring pile, construct one boat lift with associated piles and two PWC lifts, and replace in kind one boat lift with associated piles, all within a maximum of 268 feet channelward of the mean high water line.
- PORT-2025-00015 - 1 ALDEN LN  
Removal of specified failing bulkhead, installation of living shoreline & marsh creation, 134' wide by 35' Channelward of MHWL, installation of new pier orientation, 233' long by 6' wide , installation of 10' by 20' Platform area, and 3' by 16' wide finger pier.

Demo 1 pier. Install new 4' x 40' pier inside the western 5' Lateral Line Setback.
- PORT-2025-00018 - 11 SOUTHGATE AVE  
Install 1 mooring pile.
