Requests approval to extend the term of the Lease Agreement (FINAN-202580172-00) as amended under the Amendatory Lease Agreement (FINAN- 202683028-01) with The Fax East Colfax Redevelopment, LLC for 24 months to March 31, 2028. This Second Amendment to Lease Agreement (FINAN-202684480-02) with The Fax East Colfax Redevelopment, LLC is to lease 38 residential rooms/units located at 8405 and 8415 East Colfax Avenue for \$2,715,937.41. With this amendment, the new maximum contract amount will be \$3,774,899.32.

The Lease Agreement and this second amendment are in support of Roads to Recovery, which connects people struggling with addiction or mental health to a coordinated system of care as part of the All in Mile High initiative. Program participants enter a coordinated, high-touch system for immediate intervention and treatment to support long-term stability. Roads to Recovery case managers will provide services to program participants at this location.

The Fax East Colfax Redevelopment, LLC was selected through a Request for Expression of Interest ("RFEOI").
