Please submit the completed form to the Recording Secretary prior to being heard by the Commission. Each individual will be allowed three (3) minutes, unless extended by the Chair. For each separate agenda item, the Chairman may limit the total time for public testimony. No action will be taken on any items not on the agenda, unless the Planning Commission makes a determination that an emergency exists or that there is a need for immediate action and the need to take action came to the attention of the City subsequent to the agenda being posted.

If you challenge the proposed action of the Planning Commission in court, you may be limited to raising only those issues you or someone else raised at the public hearing, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing.

By Planning Commission policy, no new agenda items will commence after 11:00 p.m. If items remain after that time, they will be automatically continued to the next regularly scheduled meeting of the Planning Commission. Any documents that are provided to the Planning Commission regarding items on this agenda less than 72 hours prior to this meeting will be available for public inspection at the public review table that is located in the reception area on the first floor of City Hall at 30111 Crown Valley Parkway, Laguna Niguel, California 92677, until 5:00 p.m. on the date of the Planning Commission meeting. After 5:00 p.m., the documents will be available at the counter that is located inside the City Council Chambers at 30111 Crown Valley Parkway, Laguna Niguel, California 92677.

NOTICED PUBLIC HEARING ITEMS

1. [Zoning Code Amendment ZCA 26-0001 \(Zoning Code Update\) – PUBLIC HEARING](#)
– Amending Title 9 of the Laguna Niguel Municipal Code and finding the action to be exempt from the California Environmental Quality Act under State CEQA Guidelines section 15061(b)(3).

Recommended Action: That the Planning Commission open the public hearing, take public testimony, close the public hearing, and then take the following actions:

- A. Adopt Resolution No. 26-02 (Attachment A) recommending that the City Council approve Zoning Code Amendment (“ZCA”) 26-0001 amending various sections of Title 9 of the Laguna Niguel Municipal Code.
 - B. Find that the adoption of Zoning Code Amendment 26-0001 is not subject to CEQA pursuant to State CEQA Guidelines Sections 15060(c) and 15378 and alternatively is exempt from CEQA pursuant to State CEQA Guidelines Section 15061(b)(3).
2. [Tentative Parcel Map TPM 2026-111 \(18 Little Pond - Shaked Residence\) - PUBLIC HEARING](#) - A request to subdivide 18 Little Pond, an existing 23,195-square-foot residential parcel, into two parcels. The subject property is a double lot created through a prior lot line adjustment that merged 16 and 18 Little Pond. The proposed subdivision would re-establish the two parcels consistent with the original subdivision lot configuration for 16 and 18 Little Pond. The project site is located within the Ocean Ranch at Bear Brand residential gated community.

Recommended Action: That the Planning Commission open the public hearing, take public testimony, close the public hearing, and then take the following actions:

- A. Adopt Resolution No. 26-03 (Attachment A), approving Tentative Parcel Map TPM 2026-111, subject to conditions of approval, and finding the project

exempt from the California Environmental Quality Act (“CEQA”) under Section 15303, Class 15 (Minor Land Divisions), of the CEQA Guidelines.
