MINUTES

The Marshall County Board of Supervisors met for the special meeting according to the posted notices in the Courthouse, First Floor Meeting Room, 1 East Main Street, Marshalltown, Iowa, and online via ZOOM. Chair Heil called the meeting to order on March 25, 2026, at 5:00 p.m. Present: Chair Jarret Heil, Vice Chair Carol Hibbs, Member Christian Goodman. Goodman moved to approve the agenda second by Hibbs. Motion carried 3-0.

Marshall County Proposed Property Tax Levy Public Hearing – PROPOSED PROPERTY TAX LEVY Fiscal Year July 1, 2026 - June 30, 2027.

Motion by Hibbs, second by Goodman to open the public hearing at 5:03 p.m. Motion carried 3-0.

There were 0 written comments, questions, or objections on file in the County Auditor and Recorder’s Office. Of the 4 individuals attending the public hearing, 3 individual(s) presented oral comments, questions or objections. Chair Heil gave a brief overview of the budget as a whole and stated that valuation growth was 2.98% for this budget cycle. Nan Benson, Marshall County Auditor/Recorder, also spoke briefly and provided clarification regarding the cost increases of property insurance. Loren Shetler (Yates Ave), Linda Clark (2nd Ave, Marshalltown), and Kelly and Cynthia Smith (Sand Rd) made various comments regarding the rising cost of taxes and living on fixed incomes as well as construction and road repairs throughout the county.

Motion by Goodman, second by Hibbs to close the public hearing at 5:29 p.m. Motion carried 3-0.
