The meeting room is wheelchair accessible. Assistive listening devices and interpreters are available through the BHB Secretary. Requests for disability related modifications or accommodations, aids or services may be made to the Behavioral Health Board Secretary 's office no less than 72 hours prior to the meeting date by phoning (707) 259-8677.

All materials relating to an agenda item for an open session of a regular meeting of the BHB which are provided to a majority or all of the members of the Board by Board members, staff or the public within 72 hours of but prior to the meeting will be available for public inspection, on and after at the time of such distribution, in the office of the BHB Secretary, 2751 Napa Valley Corporate Drive, Building A, Napa, California 94558, Monday through Friday, between the hours of 9:00 a.m. and 6:00 p.m., except for County holidays. Materials distributed to a majority or all of the members of the Board at the meeting will be available for public inspection at the public meeting if prepared by the members of the Board or County staff and after the public meeting if prepared by some other person. Give your name, organization (if any), and your comments or questions. As required by the Government Code, no action or discussion will be undertaken on any item raised during the Public Comment period and shall be placed on a future agenda if required. Time limitation shall be three minutes per speaker. Any member of the audience desiring to address the Board on a matter on the agenda may do so after receiving recognition from the chairperson at the time the item is considered. Give your name, organization (if any), and your comments or questions. In order that all interested parties have an opportunity to speak, please be brief and limit your comments to the specific subject under discussion. Time limitations shall be three minutes per speaker.
