THE TAX RATE WILL EFFECTIVELY BE RAISED BY 12.5 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000.00 HOME BY APXORIMATELY \$68.05**

This Budget will raise more total property taxes than last year's budget by \$30,100 or 19.72%, and of that amount, \$11,025 is tax revenue to be raised from new property added to the tax roll this year.**
