1. Approval of Board of Public Works Minutes for the week of June 10, 2025.
2. Approval of Resolution #77392, Feighner Rd Lift Station Improvements.
3. Approval of Resolution #77497, 2025 Sewer Line Rapid Assessment Tool Contracted Inspections.
4. Approval of Emergency Resolution #112-6-17-25-1, Water Main Repair work.
5. Approval of Professional Services Agreement between the City of Fort Wayne and Purdue University Fort Wayne for WO #0995P, 2025 SS4A Grant CSAP Update. Compensation for services performed shall not exceed \$12,000.00.
6. Approval of Right-of-Way Agreement between the City of Fort Wayne and Norfolk Southern Railway Company for Airport Expressway Railroad Crossing Elimination.
7. Approval of Professional Services Agreement between the City of Fort Wayne and Baker Tilly Advisory Group for municipal advisory services for the water utility. Compensation for services performed shall not exceed \$68,000.00.
8. Approval of Professional Services Agreement between the City of Fort Wayne and Baker Tilly Advisory Group for parity reporting for the water utility. Compensation for services performed shall not exceed \$6,500.00.
9. Approval of Amendment #1 to Services Agreement between the City of Fort Wayne and Doc's Crane & Rigging for Resolution #77216, WPCP Headworks Screen Rebuild. Compensation for services performed shall be increased by \$9,822.00, bringing the total fee to \$75,274.00.
10. Approval of Service Agreement between the City of Fort Wayne and Campos Excavating for WO #67449, Plant 2 Primary Stuffing Box and Shaft Replacements Compensation for services performed shall be \$40,000.00.
11. Approval of Assignment and Assumption of Waste Hauler Contract for Fats, Oils, and Grease. This consents to the assignment of the Contract by Lone Palm LLC dba Three Sons Sanitation to CMGL Sanitation Inc. Compensation for services performed shall remain the same.

12. Approval of Owner-Contractor Agreements for 2025 WaterWorks On-Call Construction Services Agreement between the City of Fort Wayne and All Seasons Underground Construction, Midwest Trenchless Services, Fox Contractors, Underground Contractors, Pinpoint Directional Drilling and S&S Directional Boring with a not-to-exceed \$8,000,000.00 across all contractors.
13. Approval of Change Order #1 & Final between the City of Fort Wayne and Kissinger Electric for Resolution #0889N, 700-900 block Harmar Street Lighting Improvements. This change order decreases the original contract price by \$4,775.00 to a final contract price of \$50,735.00 and extends the completion date by 159 days.
14. Approval of Change Order #1 & Final between the City of Fort Wayne and Kirk Brothers Construction for Resolution #76929, WPCP Aeration Basin Diffuser Improvements Phase 1. This change order decreases the original contract price by \$451.61 to a final contract price of \$2,634,490.39 and extends the completion date by 110 days.

18. Approval of Owner-Contractor Agreement #0946D, Alley North/South: Third St, Sinclair St, St Mary's Ave and Franklin Ave between the City of Fort Wayne and Campos Excavating in the amount of \$50,000.00.
19. Approval of Owner-Contractor Agreement #0969T, West Washington Blvd and College St Signal Improvements between the City of Fort Wayne and Indoor Wireless in the amount of \$255,451.82.

Approval of Change Order #1 & Final between the City of Fort Wayne and Milestone Contractors and acceptance of the work performed for Contract #0533A, Ridgewood Dr Street Improvements upon the recommendation of Transportation Engineering. The final change order decreases the original contract price by \$58,531.62 to a final contract price of \$1,131,418.37.
24. Acceptance of the work performed by S&S Directional Boring for Contract #77117, Coldwater Rd Septic Elimination upon the recommendation from City Utilities Engineering as an integral part of the City's sanitary sewer system.
