**TESTIMONY:** Testimony will be accepted prior to discussion on each agenda item. Testifiers may only testify once per item. Oral testimony is limited to a maximum of two minutes per item. Testifiers are to provide the agenda item number and name of the item they wish to testify on. The chair will call testifiers in the following order of modalities: videoconference, phone, in-person.
